We have completed our review of the above-mentioned product. Based on the information that the Canadian Food Inspection Agency (CFIA) has reviewed, we have determined that this product meets all requirements as outlined in the *Fertilizers Act* and regulations and may be legally imported and sold in Canada. Therefore, the above product has been amended under the *Fertilizers Act* until August 3, 2028. All labels associated with this product found in the marketplace must contain the registration number stated above and as shown on the registration certificate available in My CFIA. Please note that the suffix of the registration number has been revised.

Please note that as new regulations and/or policies are developed, the acceptability of this product under the *Fertilizers Act and* Regulations may also change. It is the responsibility of the manufacturer/registrant/distributor/retailer to ensure that the product and the label continue to meet the requirements for sale in Canada, as outlined in the *Fertilizers Act* and Regulations.

Please note that an amendment to your registration must be submitted to the CFIA and approved prior to making any changes to the label (including directions for use), chemical composition, or constituent materials of the product, if the change could reasonably be expected to affect its performance as a fertilizer or supplement, its safety or its use.

As the registrant, you must be aware of the date that your product registration expires (found on registration certificate), and submit a renewal application **before**, **the stated expiry date**. Applications for a **renewal without changes** (i.e., no changes to the constituent materials, manufacturing process, or directions for use) should be submitted at least four months prior to expiration from the previous registration.

Applications for **renewals with changes** should be submitted one year in advance of the registration expiry date to provide the CFIA with adequate time to review the application and confirm that the proposed changes do not cause the product to pose an incremental risk to human, animal, plant, or environmental health. If applications to re-register products are not submitted within these timelines, the CFIA may not be able to process the application to re-





register your product before the product's registration lapses, rendering it ineligible for import or sale in Canada.

Registered products whose registrations were issued through the My CFIA electronic submissions platform will receive electronic notifications that expiry dates are nearing (and if necessary, that a registration has expired). However, it remains the responsibility of the registrant to submit re-registration applications in a timely manner to avoid a registration lapsing. Please note that the renewal must be submitted through our electronic platform My CFIA.
